Veterans Alternative provides alternative therapies, services and community engagement to Combat Veterans and their spouse or significant other. Services are primarily delivered through the five-day Accelerated Wellness Program (AWP), an effective program using Accelerated Resolution Therapy (ART), Integrative Restoration (iRest), adaptive yoga and other alternative therapies. Individualized sessions of ART are also offered to those who are unable to attend the five-day program.

In 2019, Veterans Alternative served over 157 Combat Veterans and their spouse or significant other through the Accelerated Wellness Program. The AWP is a highly effective five-day program utilizing an integrative approach of alterantive therapies. AWP participants recieve five sessions each of Accelerated Resolution Therapy (ART) and Integrative Restoration (iRest). The combination of these two therapies, in addition to other alternative therapies such as adaptive yoga, equine therapy, art and music therapy, TRX physical fitness and hydro-massage produce a highly effective program showing a 49% reduction in post-traumatic stress, 61% reduction in depression, 54% reduction in anxiety, 43% reduction in stress and other positive outcomes.
